2B. Project Description

1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with the provisions of 24 CFR 578.7.

The CoC Planning Project funds will be used to coordinate activities of the Garrett Roundtable on Homelessness. These activities include further development of Garrett County CoC policies and procedures and further development of the Garrett County CoC governance charter between the CoC lead agency, the HMIS lead agency, and other agencies participating in Garrett County's CoC. Planning funds will be used to increase data quality and reporting of the HUD required System Performance Measures. This funding allows for evaluation of PIT and HIC procedures to maximize CoC performance. GCCAC, the lead HMIS agency for the Garrett County CoC, will continue to develop the HMIS system in the coming year. Planning funding will be used to create concrete data entry procedures and reliable data quality checks. Funds will also be used to plan and facilitate an annual Homeless Resource Day. CoC staff will take the lead in overseeing the subcommittee responsible for this event.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Further development of Garrett County CoC policies and procedures is an ongoing activity. Efforts to increase data quality and reporting of the System Performance Measures is currently in development and will be ongoing. The Garrett Roundtable on Homelessness will evaluate the PIT and HIC procedures annually. The upgrade of the HMIS system by GCCAC has begun and will be ongoing. All planning activities will be monitored by the Garrett Roundtable on Homeless at each bimonthly meeting.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

By dedicating a portion of a staff salary to the CoC planning efforts, the overall function of the Garrett County CoC will improve. The CoC's upgraded HMIS system will be more capable of monitoring all CoC funded and non CoC funded projects within the CoC. Adequate measurement of CoC prioritized goals and outcomes determines effectiveness of these programs.

4. How will the planning activities continue beyond the expiration of HUD financial assistance?

The Garrett County CoC is committed to the homeless projects in this jurisdiction. GCCAC, the lead CoC agency, will continue to provide staff hours to continue this work after the expiration of HUD financial assistance.
